## **1. We respect your privacy**

- (a) OzOnCloud - TechDB Pty Ltd respects your right to privacy and is committed to safeguarding the privacy of our customers and website visitors. We adhere to the Australian Privacy Principles contained in the Privacy Act 1988 (Cth). This policy sets out how we collect and treat your personal information.
- (b) "Personal information" is information we hold which is identifiable as being about you.

## **2. Collection of personal information**

- (a) OzOnCloud - TechDB Pty Ltd collect information that you provide us online, by email, post, facsimile, face to face, over the phone or through our affiliates. In most cases the information is personal information required to provide Services to you. This may include (but is not limited to) your full name, postal address, place of business, telephone number, email address, ABN or ACN, date of birth and other information which either we deem relevant.

- (b) We may from time to time need to disclose personal information to comply with a legal requirement, such as a law, regulation, court order, subpoena, warrant, in the course of a legal proceeding or in response to a law enforcement agency request.
- (c) We may also use your personal information to protect the copyright, trademarks, legal rights, property or safety of OzOnCloud - TechDB Pty Ltd, [www.ozoncloud.com.au](http://www.ozoncloud.com.au), its customers or third parties.
- (d) Information that we collect may from time to time be stored, processed in or transferred between parties located in countries outside of Australia.
- (e) If there is a change of control in our business or a sale or transfer of business assets, we reserve the right to transfer to the extent permissible at law our user databases, together with any personal information and non-personal information contained in those databases. This information may be disclosed to a potential purchaser under an agreement to maintain confidentiality. We would seek to only disclose information in good faith and where required by any of the above circumstances.
